I faithfully adhere to this command, praying for our leaders and their wisdom in governance. This spiritual practice underscores my respect for and commitment to lawful authority, further demonstrating that the accusations of me being a 'sovereign citizen' are completely unfounded. My actions and beliefs are aligned with supporting and upholding the structure and governance of our nation, not opposing it.

I unequivocally reject and rebut any presumptions and statements made by governing officials or members of the public that label me as a 'sovereign citizen.' I firmly rely on the protections afforded by the United States Constitution under Article 4, Section 4. I am not an extremist, anti-government, anti-tax, or associated with any ideologies that fall under the sovereign citizen movement. Such allegations are not only false but dangerously defamatory, putting myself and my family in danger. By mischaracterizing me in this manner, you risk endangering my life by

inviting unwarranted scrutiny and action from the FBI, who identifies sovereign citizens as "anti-government extremists." This misrepresentation is a serious falsehood and a grave injustice, aligning me with a group known for its anti-government activities, tax protests, and pseudolegal beliefs. I stand firmly against these accusations and assert my rights as a private American citizen under the full protection of the original United States Constitution.

Order:

To all public officers, attorneys, government agents, officials, representatives, employees, agencies, departments, commissions, and authorities: You are hereby directed to refrain from referring to, addressing, or labeling me as a "sovereign citizen" in any form, whether publicly, digitally, or by parole.


